DE-SEALING ORDER

Whereas vide sealing order dated 18.01.2018 the premises of Sh. Sunny Kumar (Proprietor) of M/s Lala Bike Repairing, at Kali Ghata, Near Transformer, Karawal Nagar, Delhi-94 was sealed during the course of child rescue operation, conducted on 18.01.2018 in collaboration with Labour Department, Police & NGO (Bachapan Bachao Andolan) wherein one child labour (1) Jagdish age 15 years was rescued.


Whereas as per Dy. Labour Commissioner, Labour Department letter No. DLC/NE/Ch. Lab/2018/446 dated 09.02.2018 the age of above rescued child labour, as per the preliminary physical examination conducted by Medical Officer is, above 15 years, hence the employer is not liable to pay the compensation of Rs. 20,0000/-.

Whereas, as per the above referred letter dated 09.02.2018 the offending employer has deposited the amount of Rs. 21,700/- vide DD No. 961116 dated 20.01.2018 for the Child Welfare Committee acknowledgement vide receipt No. CWC/DG/38/18 dated 05.02.2018 of the Child Welfare Committee.

Whereas, vide above referred letter dated 09.02.2018, it has been informed that FIR has already been lodged against the offending employer under the provision of child labour (P&R) Act, 1986, J.J. Act 2000 & Bounded Labour Regulation Act.


Whereas, the Dy. Labour Commissioner, Labour Department vide dated 09.02.2018 has conveyed his no objection in de-sealing the above said premises.

Accordingly, in view of the above recommendation of Dy. Labour Commissioner conveyed vide letter dated 09.02.2018 the premises of M/s Lala Bike Repairing, at Kali Ghata, Near Transformer, Karawal Nagar, Delhi-94. is hereby ordered to be de-sealed
