ORDER

Whereas, Shantanu Coop. G/H Society Ltd., Chamber No.24, D-248/10, Balaji Complex, Laxmi Nagar, Delhi-110092 is registered with this Department vide Regn. No.1111/GH.

And whereas the society is one of the eleventh societies where land allotment process is stayed/ challenged in the Hon'ble High Court and for which verification being carried out by Local Court Commissioner. Hon'ble High Court of Delhi vide order dated 05.10.2015 in CM No.22325-26/2015 in WP(C) No.3545/2014 has directed for the appointment of Administrator-cum-Returning Officer, with further direction that the Returning Officer shall ensure conduct of the election 60ⁱⁿ days.

Vide order dated 17.09.2015 Sh. T.K. Jain was appointed as Administrator of the society. In pursuance of the aforesaid order of Hon'ble High Court, the appointment order of Administrator is hereby cancelled.

Now, the Secretary-cum-Registrar, Cooperative Societies, GNCT of Delhi, in exercise of the powers vested in her under DCS Act & Rules, appoint Sh. R.S. Krishnan, Dy. Secretary (Delhi Dialogue Commission) as Administrator-cum-Returning Officer in Shantanu Coop. G/H Society Ltd., under section 35(1) of DCS Act, 2003 read with Rule 53 and Schedule II of DCS Rules, 2007 to conduct the election of the Managing Committee of the society within a period of Sixty days from the date of issue of the order and entitle to receive Rs.6,000/- (Rs. Six Thousand Only) as honorarium out of the society funds.

This issues with the prior approval of the Competent Authority.
