S.No	Question	Answer
a.	Whether some of the Group Housing Societies have committed serious irregularities involving Crores of rupees in allotment of flats constructed on the land allotted by Delhi Development Authority (DDA)	Some complaints regarding irregularities in allotment of flats on the land allotted by DDA are received and same are redressed as per the provisions of DCS Act & Rules. Further no such case has been referred to CBI so far. However, some cases of irregularities in allotment of land were noticed in 2004-05 and CBI, as per the direction of Hon'ble High Court of Delhi, is investigating 57 such Cooperative Group Housing Societies and these cases are pending in various CBI trial Courts.
b.	If so, the details thereof and the penal action taken/being taken by the Government against such societies including outcome of cases referred to CBI in this regard?	Not applicable in light of above.
