2. As you are aware Health & Family Welfare Deptt. GNCT of Delhi vide circular dated 02.05.2019 has circulated the Medical Authorities for certifying various disabilities alongwith their jurisdiction in NCT of Delhi.

3. Certificates of Disability or Medical Certificate for GST concession, Rail Travel concession or any other medical certificate in respect of persons with disabilities should be issued by the designated hospitals / medical authorities circulated by H&FW on 02.05.2019.

Respected Sir,

I am working as Associate Professor in the department of PMR in VMMC and Safdarjung Hospital. We are facing a lot of problem regarding the issuance of medical certificate for GST for purchase of vehicle by PWDs. In the application format it is written that "A medical certificate from the medical officer of the government Hospital in prescribed format placed at Annexure B" should be annexed. According to the above mentioned instructions any medical officer can issue but PWDs are referred regularly to Department of PMR for the same. It is not appropriate that for a medical officer's work, some specialist/ consultant has to be approached. In the format they are not asking for the PMR expertise so why patient should be referred to PMR department. All these patients have disability certificate with them so they should go to their hospital where the disability certificate was made. All the hospitals have standing medical boards with required specialists so they can easily go to the same for easy and early certification. The present situation is that every hospital is sending these PWDs to Safdarjung Hospital for needful and here everyone is coming to PMR department. I have my doubts in filling these forms so have my other colleagues. I can't assess PWDs medical, mental, hearing and vision assessments in PMR department and how can I verify his disability given by some other specialist as required in the application format. When we sent these PWDs to their hospital of D.C. they are creating a lot of problem, abusing and fighting with us.

Same problem is coming even with driving license medical certificates to be issued to PWDs. The format again requires assessment of medical, mental, hearing and vision assessment along with mention of disability percentage.

In the interest of PWDs, you are requested to sort out this matter on an urgent basis.

I am attaching the application format for your reference.
