


Decision of Industrial Land Management Advisory Committee (ILMAC):


This case was taken up in view of Previous minutes of the ILMAC dated 25.01.2011. Earlier the Claimant Sh. Swinder Kumar, after the death of his father (Ailotee) had submitted Relinquishment deed from his mother only and his case was approved the year 2006. Later on the possession was handed over to Sh. Swinder Kumar but lease was not executed. Later on his mother made complaint to stop the lease informing that plot should have been in her name instead of her son. Matter came in ILMAC on 31-08-2010 and 25.01.2011. When mother and son both were present.
