

MINUTES OF THE MEETING OF COMMITTEE CONSTITUTED UNDER
RULE 90 OF THE DCS RULES, 2007 HELD ON 07.06.2013 AT 4:00
P.M. UNDER THE CHAIRMANSHIP OF SECRETARY (COOPERATION).

(150) A meeting of Committee constituted under Rule 90 of DCS Rules, 2007 was held on 07.06.13 at 4:00 P.M. to consider the proposal for clearance of membership for draw of lots in r/o Smt. Manjeet Kaur M.S. No.615 of Jagriti Nagar CHBS Ltd.

(151) Jagriti Nagar CHBS Ltd. is registered with this department vide registration no. 2183 dated 01.01.1975 and land was allotted to the society at Jagriti Enclave, Vikas Marg Extn. Delhi-92. The Freeze strength is 470 members. The name of 447 members out of 470 has already been cleared by RCS from time to time. The case of Smt. Manjeet Kaur M.S. No.615 was detained for the reasons given below:-

(152) Now Hon'ble High Court vide its judgement dated 17.08.09 in WPC No. 4256/2008 in the matter of Manjeet Kaur V/s RCS and Anr. held that she is entitled to an allotment of a plot in the society subject to her filling an affidavit indicating that :-

1. She got married in the year 1980 and that, a year later she and her husband separated and they have been living separately since then; and
2. That neither she nor her husband owned any property in Delhi and particularly flat No. 103 at Amit Cooperative Group Housing Society and/or flat No. K-28D, Saket, New Delhi.

In compliance of Hon'ble High Court order Smt. Manjeet Kaur filed an affidavit on 11.04.11 in the office of the society and society forwarded the same to the O/o RCS vide letter dated 23.04.11.

Further society forwarded the proposal as per Schedule-VII to the O/o RCS vide letter dated 09.08.11 for clearance of membership in r/o Smt. Manjeet Kaur M.S. No. 615.
