ORDER

Whereas New Vikas Cooperative Thrift and Credit Society Ltd., 2629/197, Onkar Nagar, Tri Nagar, Delhi-110035 is registered with this department at Regd. No.23/TC/Sec-5 under the provisions of DCS Act, Rules and bylaws of the society.

Whereas the members of Society vide letter dated 29/09/2015 requested RCS Office to appoint a Returning Officer to conduct the election of the society as the term of MC is ending on 6th October 2015.

Whereas, Management Committee of society appointed Sh. Nand Kishore as Returning Officer vide resolution dated 02/08/2015 and accordingly Sh. Nand Kishore, issued agenda notice for the election of the society to be held on 04/10/2015.

Whereas Returning Officer vide his letter dated 29/09/2015 addressed to the RCS informed that upon his appointment as Returning Officer by the Society he completed all formalities for conduct of elections but Society is now not interested to conduct free and fair elections. He further requested that the RCS Office should look into the matter and take prompt action to conduct free and fair election.

Now, therefore, in exercise of the powers vested in her U/S 35 (5) of the DCS Act, 2003, the Competent Authority is pleased to appoint Sh. Bipan Kumar (Retd. DANICS) as Returning Officer for holding the election of the Managing Committee of the aforesaid Society as per provision of DCS Act, 2003 DCS Rules, 2007 and Bye-laws/Model Bye laws of the society within 90 days from the issue of this order. The expenses of the election will be met out from the funds of the Society.

The Society is further directed to furnish the relevant documents/papers to the Returning Officer within 07 days from the issue of this order. Sh. Bipan Kumar (Retd. DANICS) shall be paid Rs. 6000/- (Rupees Six Thousand only) for conducting election to the Managing Committee of the Society from society fund.


