ORDER

Whereas a inspection was carried out on 02.08.2014 at the premises of Sh. Kunwar Pal S/o Sh. Ram Swaroop, Patwari Compound, Nahar Road, Gokalpuri, Delhi-94, in the compliance of public Notice No. F.36(162)/Coord./Div.Com./2013/66 dated 08.01.2014 of Revenue Department, O/o Divisional Commissioner, Revenue Department, 5 Sham Nath Marg, Delhi-54 in compliance of order of Hon'ble Supreme Court in WP (Crl.) 129 of 2006 Laxmi Vs. U.O.I. & Others on 18.07.2013 vide which the Hon'ble Supreme Court has issued certain directions regarding the sale of Acid/ Corrosive substances, and


Whereas, during the inspection of Sh. Kunwar Pal S/o Sh. Ram Swaroop, Patwari Compound, Nahar Road, Gokalpuri, Delhi-94 was not able to produce the log/ stock register or any records pertaining to the sale / purchase/ stocking of Acid as per the instructions / directions published in the Public Notice on 08.01.2014, which is a violation of direction of Hon'ble Supreme Court.

Now, therefore, I am of the considered opinion that a penalty of Rs. 5,000/- (Five Thousand Only) be imposed on Sh. Kunwar Pal S/o Sh. Ram Swaroop, Patwari Compound, Nahar Road, Gokalpuri, Delhi-94 for the above said violation and he is also directed to close down the business of sale of purchase of Acid is obtained from the competent authority.

SHO (Gokalpuri) is also directed to ensure that no activity regarding sale of purchase of acid be carried out at the said premises without valid permission or license.
